Membership Types and Annual Fees

Four types of membership

Financial members (with voting privileges)

- Corporate membership: A\$200 p.a.
- Individual membership: A\$100 p.a.

Associate members (without voting privileges)

- Corporate membership: A\$100 p.a.
- Individual membership: A\$50 p.a.
- Individual Regional: A\$50 p.a.
- Individual Academic: A\$30 p.a.
- Individual Student: A\$10 p.a.

- Applicable fees: None
- Voting privileges: None

Membership Terms and Conditions

Sponsorship

New members must be sponsored by at least one financial member of CCIAP Inc and be seconded by another financial member.

Financial members

- Financial members are entitled to vote and enjoy all other membership privileges.
- Financial member with a corporate membership are allowed a maximum of 3 people; with only vote allowed.
- Financial member with an individual membership is allowed one vote.

Associate members

- Associate members enjoy membership privileges except voting rights.

Corporate membership:

- Associate members with a corporate membership are allowed a maximum of 3 people.

Individual Regional membership:

- An Individual Regional member is defined as one who resides outside Southeast Queensland which includes Beaudesert, Boonah, Brisbane City, Caboolture, Caloundra City, Cooloola, Gold Coast City, Ipswich City, Kilcoy, Logan City, Maroochy, Noosa, Pine Rivers, Redcliffe City and Redland.

Affiliate membership

Affiliate members are members of organizations or clubs who enjoy reciprocal membership privileges without the obligation of paying membership fees except the right to vote.

Honourary Membership

Honourary membership is bestowed to individuals by Executive Committee decision who have rendered outstanding and exceptional service to the Chamber. Honourary members enjoy the privileges of an Associate Member without the obligation of paying the annual membership fees.

General

- Membership is for one year commencing in July up to June the following year.
- Membership renewed within 2 months of expiry date (to Aug 31) will be considered a RENEWAL.
- Membership renewed after 2 months of expiry date (from Sept 1) will be considered as a NEW APPLICATION and is subject to new membership application approval.
- Membership fee paid by NEW APPLICANTS shall be pro rated for the current and the following year.
- Members are subject to the Chamber's Constitution, Policies and Rules.
